■ kabu.com's PTS Update

Comparing with the past statistics data, kabu.comPTS reported that in October 2009 trading increased 50% to 36.5 billion yen in terms of traded value. The number of trades and traded volume a day set new records, 5,615 and 2,246,000 respectively. Kabu.comPTS's traded volume has improved by the increasing preparation of brokers-dealers for upcoming launch of the TSE arrowhead next year. Furthermore, kabu.com continuously follows the innovation that TSE will replace the new generation platform from early 2010. Kabu.comPTS, having same auction method of price formation as does TSE, is improving liquidity in its venue with expanding the global market data feed service.
